Fairchem Organics Limited manufactures oleochemicals and nutraceutical ingredients derived from vegetable oil refining by-products and has nearly three decades of operating experience. The company runs an integrated manufacturing facility established in 1995 and produces key products such as Dimer Acid, Linoleic Acid, Monomer Acid, Isostearic Acid, and Mixed Tocopherols. It holds a strong domestic position in select fatty acid categories and exports to multiple international markets. The business benefits from long-term customer relationships and a focus on value-added product expansion and export growth.

2 Business Segments

Oleochemicals : The Oleochemicals segment is the core revenue contributor, focused on manufacturing value-added fatty acids derived from vegetable oil refining by-products. The portfolio includes Dimer Acid, Linoleic Acid, Isostearic Acid, Monomer Acid, and other distilled fatty acids catering to applications across paints, inks, lubricants, cosmetics, and specialty chemicals. The segment benefits from a cost-efficient waste-to-value manufacturing model and diversified end-use industries.

Nutraceuticals : The Nutraceuticals segment focuses on producing value-added ingredients derived from vegetable oil by-products, primarily Natural Mixed Tocopherol Concentrate (natural Vitamin E) and Concentrated Sterols. These products are used across food, pharmaceutical, cosmetic, and FMCG applications and are largely supplied to global customers. The segment supports diversification through export-oriented demand and caters to industries driven by health and nutrition trends.

- Differentiated waste-to-value manufacturing model using vegetable oil refining by-products to create value-added oleochemicals.
- Leading domestic position in select fatty acid categories supported by process expertise and cost-efficient operations.

- Continuous focus on product diversification, forward integration, and R&D-led innovation.


4 Key Growth Drivers
